Camp Kudzu is in its 18th year of operations as one of the nation's premier camps serving children who suffer from type 1 diabetes (insulin dependent). Camp Kudzu provides vital education in a setting that gives each child the best chance to learn the life skills necessary to manage this disease and helps these young people connect with peers who also have diabetes. Our mission is to educate, empower and inspire these children through a multitude of programs offered throughout the year. We serve more than 700 children and their families each year and we rely almost entirely on community philanthropic support.
